In accordance with the Articles 6.1 and 7.1 the Status of our Association and the decision of the Board of Directors dated on January 20, 2020, the amount of the annual membership fees is currently fixed as follows: 80€

We remind that all new members must pay their dues no later than the day of the given approval by the board of directors. The amount of the contribution is for a period of one calendar year and is reduced pro rata temporis, on a monthly basis, by twelfths, when membership occurs during the year. Any contribution paid in the first financial year shall be valid for the whole of that financial year until December 31. The reafter, contributions will be payable on January 1 of each year. The board of directors may change the amount of the contributions, without retroactivity. The subscription are not subject to repayment and cannot be redeem.

Upon receipt, we will send you a receipt attesting to the payment of your contribution. The contribution is not subject to VAT and does not give rise to the issue of an invoice. It does not give right to the profit of provisions of the 200 , 238 A and 885-0 V A A of the General Tax Code.

We remind in accordance to articles 6.3 and 10.1 of the status of our association, in absence of payment of the contribution within the required time, you could not participate in the next general meeting and you may be subject to a delisting procedure.
